Üsküdar University offers scholarship opportunities in undergraduate and graduate programs in order to reduce inequalities of opportunity for disadvantaged groups. Our university aims to include under-represented groups in higher education with options such as special deprivation scholarships, instituation scholarships, foreign student scholarships and disabled student scholarships, sports scholarships, and ÖSYM success scholarships in admission to undergraduate programs. Special deprivation scholarships are also offered to students in master's programs. Although the scholarship and discount opportunities offered are available to everyone on our university's website, the scholarships in question are collected in a file and presented as evidence. 

10.6.7. Does your university as a body provide accessible facilities for people with disabilities?

Yes. The university is engaged in systematic endeavors to foster equity and inclusivity by facilitating equal access for disadvantaged and special-needs students across the realms of academic, physical infrastructure, and social resources. Across the entirety of Üsküdar University's diverse campuses, rigorous measures have been meticulously implemented to

facilitate the accommodation of individuals with disabilities. These measures encompass the presence of accessible ramps leading to university buildings, specifically designed turnstiles at entry and exit points for the ease of disabled individuals, disability-compliant elevators within building structures, as well as standardized accessible restrooms available on each floor. Additionally, specialized workstations and computer desks have been thoughtfully arranged to cater to the distinct needs of special-needs students. Furthermore, tactile surfaces, also referred to as detectable warning surfaces, are strategically embedded throughout the campus environment to provide sensory cues and directional guidance to visually impaired individuals. All elevators in the university's campuses have been designed to be accessible for individuals with disabilities.



Disabled toilets in accordance with the standards are available in all our units. There are warnings, signs and signs for students with special needs. Disabled ramps are available at the entrances, exits and in all required areas. Tactile flooring (visually impaired walkway) is a globally accepted flooring system for the visually impaired, applied indoors and outdoors. Guideways made with this floor system provide superior walking ability for visually impaired citizens. Tactile surfaces are designed to be used for our visually impaired individuals in public institutions and organizations, hospitals, municipalities, etc. in many areas.

10.6.8. Does your university as a body provide support services for people with disabilities? (e.g. personal assistants, interpreters)

As a Üsküdar universty, we have a policy text named "Üsküdar University Education and Exam Practices Directive For Students with Special Needs" created by university administration. This unit was created to identify the needs of students with disabilities for academic, administrative, physical, psychological, social and welfare needs and determine what needs to be done to meet these needs. In order to achieve these goals, two groups, namely the disabled student unit commission and academic commission representatives, were formed. Disabled student unit commission generally provides the management of the unit. The other team was formed by selecting a representative academician from each faculty. Since students with disabilities are in direct contact with academics during their education and examination processes, the support of academicians is received in the services offered to students with disabilities. 10.6.9. Does your university as a body provide access schemes for people with disabilities?

Yes. As a Üsküdar University, providing Access schemes for the disabled is part of our corporate identity. We provide some basic accessibility facilities for the disabled in each of our campuses. For example, services such as tactile surface, disabled elevator, disabled toilets, elevator buttons, campus floor plans, and toilet signage conversion into braille are provided to all our campuses, including our recently opened campus. In addition, sign language courses are given for the hearing impaired in the social services and audiology departments of our university. In addition to all these, we strive to ensure that individuals with disabilities have equal opportunities in both social and academic life, as we act with the corporate slogan of "barrier-free university". For this purpose, Uskudar university, founded within ENMER (accessible research and Application Center for life support). For disabled student, there is also Disability Student Unit within the structure of Üsküdar University Health Culture and Sports Directorate. The disability student unit is tasked with conducting studies to ensure that students who are studying in our university and have special needs due to any disability can reach all the facilities in the university as comfortably as other students. By Disabled Unit; All of our 6 ring services (shuttle) are suitable for the use of disabled students. The exam schedule of our disabled students is closely monitored, the responsible faculty members are informed, and the supervisors consist of faculty members. Meetings regarding the online education system are held and studies are carried out according to students' feedback. Disabled students can use our gym free of charge. Student lockers on our campuses are provided free of charge to our disabled students. A common WhatsApp group has been established to ensure easier communication with our disabled students. Disabled students who apply to the Psychological Counseling Unit can receive free individual counseling services in line with their needs and demands. The Institute/Faculty and Vocational School of Health Services Directorate decided to hold the exams of our hearing, visually and physically disabled students as requested (additional time in exams, special exam paper, use of special materials in exams, etc.) and the relevant instructors were informed about these students. The scholarship/payment facility request petitions of our disabled students who apply to the Solution Center Unit are evaluated by our Board of Trustees and feedback is given to their petitions by the Scholarship Commission. https://uskudar.edu.tr/enmer/en

Üsküdar university adopts an approach that considers the needs of disabled students in the processes of organizing courses and examinations. Online platforms include various options such as Zoom, Microsoft Teams, and ALMS. Courses and examinations conducted on these platforms are structured in a manner that takes into account the requirements of disabled students. Additional time is allocated to these students during the exam preparation phase.

Regulations and accommodations for people with disabilities are in place at Üsküdar University. The "Üsküdar University Disabled Students Unit Structure and Working Principles Directive" provides a reasonable accommodation in the context of policy.

Our libraries are always striving to become Accessible Libraries so that every student has equal access to educational opportunities. Every academic year, the SKS Department is contacted via EBYS to obtain information about our visually impaired students. Through student interviews, information is provided regarding the use of library resources and "Accessible Library Indexes." In order to minimize physical inequalities, the YORDAM firm designed this kiosk with the OBSTACLE-FREE feature, which enables students to complete loan-return-scan procedures by modifying the screen size and height with audio/silent assistance. A separate plan has been made for the student's exams in order to reduce the difficulties that our physically disabled student will experience in

transportation to university. Scholarships to be given to disabled students are also regulated within the Üsküdar University scholarship directive.

Therapist who works in the psychological counseling unit Görkem ALTINTAŞ has a sign language certificate. She can serve also disabled clients when they need. As Üsküdar university, we have special emphasize about young people both disadvantageous and not disadvantageous. There is a research and application center named "Globalization and Youth Problems Application and Research Center." "Directing the energy of youth in the right way and directing the future of our society should be the most important duty of all organs working with young people. Globalization and Youth Problems Application and Research Center, founded on this awareness, aims to combine the youth energy with the guidance of experience and wisdom; In this way, it tries to ensure that this national treasure is properly utilized by developing solutions for the problems that young people encounter and by carrying out studies that will enable their potentials to come to life.
